The SAVE Foster Program was designed to be an extension of the shelter to provide temporary loving homes for a potentially adoptable animal whose current condition may not be manageable in a shelter setting. Although previous fostering experience is not required, ideal foster care providers should have basic knowledge of animal care and training and be committed to finding their foster animal a safe and loving “forever home”. As a foster care provider, you will provide the animals with care including food, water, shelter, training, socialization and grooming. Fostering a shelter animal is a wonderful, rewarding experience but can also be time consuming and hard work. Please seriously consider all aspects of fostering before deciding to apply to foster. ***If you are still interested, all foster care providers are required to complete the following application.***

Please read through the following foster policies and initial to indicate that you agree to comply.

_____ I agree to comply with all local and state laws and ordinances relating to the care of domestic animals, and will not engage in any illegal activity with my foster animal.

_____ I understand that no foster animal is allowed to be outside unattended and/or unrestrained.

_____ I understand that no foster animal is allowed to be left unattended with children.

_____ I understand that the animal I am taking into foster care may not be used to living indoors and may scratch or soil my furniture or belongings. If my foster animal is destructive, I will confine my foster animal to a safe area where it can not do damage and will work positively to modify its behavior.

_____ I will use positive reinforcement for training and will not use any kind of physical punishment regardless of behavior issues.

_____ I understand, like many cats, my foster cat may scratch on furniture, clothing or other objects. The shelter is NOT responsible for any damage that may occur in your home.

_____ I understand that there are no guarantees of the behavior, health or disposition of my foster.

_____ I understand that there is some (minimal) risk to my own animals, especially if the foster animals are not kept separate. I understand that the shelter is not responsible for my own pet's medical treatment.

_____ I understand that any medical treatment is to be performed by SAVE's veterinarian. If any medical care/treatment is performed by a veterinarian other than an approved SAVE veterinarian, I understand that SAVE will not reimburse me for my expenses. I also agree to provide SAVE with any/all veterinary records for treatments performed by outside veterinarians.

_____ I understand that the shelter environment is very stressful and my foster animal may take some time to adjust to new situations, people and other animals in the home.

_____ I agree that I will not leave my foster animal in the care of another person, including potential adopters, without approval from SAVE.

_____ I understand representatives from the shelter may need to contact me to discuss the foster pet. I agree to be entirely honest and forthright in regard to my foster pet's condition, be it positive or negative.

_____ I agree to work with the shelter to find a 'forever home' for my foster animal. Including; responding to internet/email inquiries, attending pet store adoption days, meeting with potential adopters and visiting the shelter to finalize the adoption.

_____ I understand that SAVE, A Friend to Homeless Animals is the legal guardian of my foster animal. I understand the shelter and its representatives have the final authority in regard to the animal's adoption, treatment or disposition.
